If a certain charge/payment has multiple transactions under the same name, the system automatically totals these transactions and lists this total under “Amount (\$).” The rows under “Description” that have arrows by them can be selected to expand a certain charge/payment category in order to show each individual transaction. For example, as shown above, though the subsidized loan was entered as one payment, it applied to tuition and general fees as two separate transactions on the same date.

NOTE: Positive amounts denote a charge to the account, negative amounts denote a payment or credit to the account.
